Subject **Adjustments to ARB's General Rules**

1. Summary

To approve the changes which need to be made to the General Rules as a result of the changes to the Architects Act 1997, and to agreed that the Rules will become effective from 7 January 2019.

2. Recommendations

It is recommended that the Board:

- i) Approves the changes to the General Rules as outlined in **Annexes A and B**; and
- ii) Agrees that the Rules will become effective from 7 January 2018.

3. Open Session

4. Contribution to the Board's Purpose and Objectives

The updating of the General Rules to reflect the recent changes to the Architects Act 1997 will enable ARB to continue the delivery of its strategic aims and fulfil its requirements under the Act.

5. Key Points

- i. Under Section 23(1) of the Architects Act 1997, the Board may make rules generally for carrying out or facilitating the purposes of this Act. The Board has established a set of General Rules for this purpose.

On 31 August 2018, the Government published a [Statutory Instrument](#) which makes changes to the Act in relation to the constitution of the Board and the Professional Conduct Committee. The revised legislation comes into effect on 7 January 2019.

The Board's General Rules require some updates to be made to them as a result of the some of the changes to the legislation so that key areas of the Rules will realign with the revised Act and the Board can continue to operate in accordance with the

revised Act when it is first appointed.

- ii. The Board is asked to note that when it is establishing or updating its Rules, the Architects Act 1997 requires that a revised draft of the General Rules is published to provide the opportunity for representations to be made. The Act does not specify the method of publication nor the length of time any proposed updates should remain available when published. The Board may therefore determine this.

On the basis that the proposed amendments to the General Rules are required due to changes in legislation the Board agreed, at its meeting of 29 November 2018, to make the draft of the revised General Rules available on its website for a period of 14 days.

Details of the proposed adjustments which were issued for comment can be found at Annexes A and B.

No representations were received in response to the publication of the revised Rules. As a result, the Board is asked to approve the changes to its General Rules as outlined above.

- iii. The Board is asked to note that provision for the Vice Chair has been removed in the proposed revised version of the Rules. Neither the current Act nor the revised Act makes provision for a Vice Chair. This is therefore an area that the new Board should discuss once it has become established, i.e., whether it wishes to create a position for a Vice Chair and what processes it wishes to use in order to select a Vice Chair. In the event the new Board wishes to select a Vice Chair, an election process could be added to the General Rules. The revised Act does also enables the Board to make Rules to allow it to appoint a person to act as Chair of the Board for any period when there is no person appointed and to appoint Board members on a temporary basis in prescribed circumstances. Again these areas will be looked at by the new Board once it has become established. The new Board may wish to review other areas of the Rules and/or it may also need to make further adjustments to the General Rules in 2019 as a result of any legislative changes which result from the UK's exit from the EU.

6. Resource implications

The changes will incur very few additional costs. Adjustments to the website version of the General Rules will need to be made. We no longer print hard copies of the General Rules and therefore no printed versions require adjustment.

7. Risk Implications

It is imperative that the Board's General Rules align with the relevant legislation. Any lack of alignment could cause issues in terms of ARB's ability to deliver its statutory functions and lead to poor governance arrangements. Updating the Rules so that they become effective from the same date as the new legislation becomes effective will ensure that the organisation and the new Board can continue to operate under the revised Act.

8. Communication

Some adjustments are being made to the Architects Act 1997 in relation to the constitution of the Board and the Professional Conduct Committee which, subject to the Board's approval, will become effective on 7 January 2019. The Board is updating its General Rules to reflect these amendments. The Board issued a draft of the revised General Rules for a period of 14 days to allow any interested parties to provide any representations they wish to make. Details of this opportunity were promoted through ARB's E-bulletin following the Board meeting and were made available via ARB's website. Any representations received were considered by the Board on 19 December 2018. The new Board may wish to undertake a wider scale review of its Rules once it has become established.

9. Equality and Diversity Implications

We have looked at whether the changes have any equality and diversity implications and have not identified any.

10. Further Actions

If approved, we will update and publish the revised Rules on ARB's website in early January 2019.
